#### **Clause 1 Objective**

## **Clause 4 Grantee's responsibilities**

4.1 The "grantee" agrees to receive research funding from the "grantor" in the amount of ......), with the disbursement of funds in installments according to the research funding agreement of Rangsit University for remuneration and other expenses by Rangsit University Regulation on Promotion of Research, 2005.

4.2 The "grantee" acknowledges and understands the regulations of the "grantor," which are in effect on the date of this contract. The grantee agrees to be bound by such regulations and will strictly follow.

4.3 The "grantee" will conduct research with perseverance to accomplish the purpose of the "grantor" by date ...... If any obstacles occur during the process of conducting research, the "grantee" will report to the "grantor" in a written paper immediately and the "grantee" will report the results on time according to the regulations.

4.4 The "grantee" agrees to abide by the rules governing the disbursement of funds and the delivery of any important papers in an efficient and cost-effective manner. In the event of overpayment, the "grantee" agrees to accept the entire charge of overpayment.

4.5 The "grantee" certifies to submit a summary report at the end of the year of the grant in every six months from the date of signing the contract even if the research is not yet complete. When the research is complete, the full report will be sent in accordance with the terms determined by the "grantor".

4.6 The "grantee" must present the research paper at the academic conference of Rangsit University or other conferences in both domestic and international under the approval from the "grantor".

4.7 When disseminating information about the research project in any publications or any media, the "grantee" must include in Acknowledgments: "Funded by Rangsit University".

# Clause 5 Ownership of intellectual property and responsibility

5.1 Intellectual property rights of any research contributed to this research funding as the joint rights of the "grantor" and the "grantee".

5.2 The "grantee" consents to the copyright and / or patents of the researched contributions funded by Rangsit University. It is the right of both "grantor" and "grantee" to share ownership of the research project. When the "grantee" publishes the research results, the "grantee" must mention the grantor in the Acknowledgment section.


5.3 The "grantee" agrees to let the "grantor" publish all research results or some parts in both printed and documented versions and distribute online through the Internet.

5.4 In disseminating information or commenting on the above research results in any publication or media, the "grantee", commenting on the research results, must be solely responsible as the person involved and must include the statement: "The grantor is not responsible for any of the above comments."

#### **Clause 6 Termination and reimbursement**

If the "grantee" fails to comply with any of the provisions of this contract or cannot continue the research, and the allocation of funding, the "grantor" considers the action to be unreasonable and the "grantor" has the right to terminate this contract immediately. The "grantee" agrees to return all the funding received with interest at the highest legal rate from the date of the funding to the "grantor" and will not claim any damages from the grantor.

The contract is made in two copies with the exact text. Each party shall hold a copy of the contract. Both parties have read and understand the terms of this contract throughout. It was signed and witnessed as evidence.
